

Orders for single regular products* (Poland and Export)

- A** Products in stock | Advanced payment of 100%
- B** Products available on request | Advanced payment of 30%, the remaining amount need to be paid before delivery (booked in the bank account)

Orders for single irregular products** (Poland)

- A** Without assembly | Advanced payment of 50%, the remaining amount need to be paid before delivery (booked in the bank account)
- B** With assembly | Advanced payment of 50%, 30% need to be paid before delivery (booked in the bank account), 20% need to be paid after the assembly

Orders for single irregular products** (Export)

- A** Without assembly | Advanced payment of 50%, the remaining amount need to be paid before delivery (booked in the bank account)
- B** With assembly | Advanced payment of 50%, 40% need to be paid before delivery (booked in the bank account), 10% need to be paid after the assembly

Orders for comprehensive equipment*** (Poland)

- A** Without assembly | Advanced payment of 30%, the remaining amount need to be paid before delivery (booked in the bank account)
- B** With assembly | Advanced payment of 30%, 50% need to be paid before delivery (booked in the bank account), 20% need to be paid after the assembly

Orders for comprehensive equipment*** (Export)

- A** Without assembly | Advanced payment of 30%, the remaining amount need to be paid before delivery (booked in the bank account)
- B** With assembly | Advanced payment of 30%, 60% need to be paid before delivery (booked in the bank account), 20% need to be paid after the assembly

Orders financed by leasing (Poland)

- A** Without assembly | Advanced payment 20%, the remain amount need to be paid before delivery (booked in the bank account)
- B** With assembly | Advanced payment 20%, 80% need to be paid after the assembly

Additional conditions:

- 1** Additional 2% of discount for 100% of prepayment for irregular products and comprehensive equipment
- 2** Deferred payment available for budget institutions
- 3** Deferred payment available for regular customers (conditions to be agreed)

*Single regular products - furniture and devices with popular parameters / e.g. a table with shelf 1000x600x850 h or a convection oven

**Single irregular products - furniture and devices characterised by high non-typicality in relation to popular devices / e.g. bar furniture designed individually and matching only the customer's place or a gastronomic cart

***Comprehensive equipment - a set of furniture and devices, regular and irregular, that make up the equipment of the customer's restaurant

The difference of payment policy between single irregular products and comprehensive equipment:

- A** Single irregular products: 50%, 30%, 20% - the percentage of „irregularity“ in the contract is probably 100%. If the order is not picked up, there is a good chance that the product cannot be resold
- B** Comprehensive equipment: 30%, 50%, 20% - the percentage of „irregularity“ in the contract is only a part of it. If the order is not picked up, it is possible to sell some products
